#### **Project Description**

The City was awarded a Prop 81 grant that will pay for the engineering and development of design plans and the implementation of two wells that will provide City park irrigation. This design and engineering is now 50% complete and will provide the required engineering and plans for the construction of additional wells as funding is made available. There remains other high priority well sites that the City would like to implement as soon as the design documents are complete. Implementation will cost \$200,000/well.

These well projects are CEQA exempt and only require City permits. Of the 21 parks in the City, the four (4) high priority well sites are:

- 1. Gavin Park
- 2. Circle Park
- 3. Ellis Lake (B Street location)
- 4. Plaza Park

#### I. Project Rationale/Issues Statement
