PROJECT DESCRIPTION

Firewise USA is national program administered by the National Fire Protection Association (NFPA) that provides a framework that communities can follow to build long term resilience to wildfire. Following this framework leads neighborhoods from 8 to 2500 households in size (known as Firewise Sites) to national recognition and eligibility for a growing number of benefits including discounts on fire insurance premiums, in addition to a long-term Action Plan to build and maintain wildfire resilience. Firewise Sites work together to maintain defensible space, share knowledge, and build a culture of wildfire preparedness and resilience.

Neighboring counties such as Nevada County have created very successful Firewise programs, led by the Fire Safe Council of Nevada County and an active network of volunteers. Developing a similar program that meets the needs of Yuba County residents and builds individual engagement in wildfire preparedness is a top priority for the Yuba Watershed Protection and Fire Safe Council (YWPFSC).

With the help of a YWA grant in 2019 and a small group of volunteers, YWPFSC has worked to encourage the development of Firewise Sites and thereby improve the wildfire resistance of our communities. Continuing to grow the capacity of this program is essential to address the urgent nature of wildfire risk in the Yuba Foothill communities. As the program grows, YWPFSC will continue to lead overall coordination and technical assistance, and will work with partner organizations and Community Leaders from each of our five fire districts to provide outreach and coordination support to individual Firewise Sites throughout the Site development process. Camptonville Community Partnership's Yuba Emergency Preparedness (YEP) project will be the pilot Community Leader for the Camptonville area and will develop procedures and templates for outreach and engagement that can be replicated in other communities.

PROJECT RATIONALE/ISSUES STATEMENT

Now more than ever, the Yuba County Foothills are faced with the growing risk of climate change and catastrophic wildfire. Across the region, the wildland urban interface (WUI) includes 9,000 residential and commercial structures scattered across a 254,000 acre landscape of mixed forest types, much of which is rated very high fire hazard severity. In the last two years alone, over 51 homes have been destroyed by wildfires in Yuba County. The neighboring Caldor, Dixie, North Complex, and many other fires that consumed vast landscapes and communities emphasize the local need to quickly build community wildfire resilience. Empowering the community by developing Firewise Sites is one tool to address this need.

Currently, the Forbestown Firewise Community, which straddles the border with Butte County, is the only Firewise Site in Yuba County. YWPFSC aims to change this by engaging communities and residents in the Firewise USA program, and providing tools and assistance to guide residents through the Site development process. The Yuba Foothills hold the potential for tens or even hundreds of Firewise Sites that are actively working together to build community resilience to wildfire. Building this network of local-scale Sites will ultimately provide wildfire resilience on a regional scale.


